You understand and affirm that all donations made through the Bitcoin Super Highway platform are voluntary, and guarantee you nothing in return.

1. You understand that there are specific guidelines and policies in place. Bitcoin Super Highway is a Crowdfunding Platform and funds are donated to the system and then assigned to specific bitcoin accounts to be dispersed as directed by the program.
2. By joining Bitcoin Super Highway, you will have 48 hours to upgrade your account to Stage 1. You will have additional options to upgrade to Stages 2-4. Failing to upgrade will cause the system to skip you on subsequent upgrades that might be assigned to you. If you fail to upgrade your position to Stage 1 within 48 hours, you will have to re-enter the system when you are ready to participate in the crowdfunding program.
3. Under no circumstances, including negligence, shall anyone involved in creating, producing or distributing this service, be liable for any direct, indirect, incidental, special or consequential damages that result from the use of, or inability to use this service, and all the files and software contained within it, including, but not limited to, reliance on any information obtained through this service; or that result from mistakes, omissions, interruptions, deletion of files or e-mail, errors, defects, viruses, delays in operation, or transmission, or any failure of performance, whether or not limited to acts beyond our control, communications failure, theft, destruction or unauthorized access to our records, programs or services.
